## Interoperability Efforts Towards New Platform Members and TEFCA Alignment

The CommonWell Health Alliance recently announced significant updates to its health data exchange platform, including the integration of new features and the inclusion of new members. These advancements follow its commitment to the Trusted Exchange Framework and Common Agreement (TEFCA), a national initiative to ensure secure, efficient, and standardised healthcare data sharing across providers. As one of seven qualified health information networks (QHINs) under TEFCA, CommonWell is expanding its reach and improving healthcare interoperability, benefiting over 36,000 healthcare providers and millions of patients across the U.S.

### Enhanced Capabilities of the CommonWell Platform

CommonWell's upgraded platform is built in collaboration with ELLKAY, a vendor specialising in healthcare interoperability. The updated system enhances the secure exchange of patient data across a growing network of healthcare providers, ensuring compliance with national standards set by TEFCA. The new platform introduces more efficient workflows, better integration, and improved onboarding processes for healthcare organisations adopting the service. One notable improvement is its security infrastructure, now certified by HITRUST, a gold standard for protecting sensitive health data. These upgrades ensure smoother communication between different health information systems, making it easier for healthcare providers to access crucial patient data when and where it is needed.

Among the first members to go live with the updated platform are athenahealth, ModuleMD, and Solace Health, all key players in healthcare IT. Their participation helps ensure that health information exchange is faster and more reliable across the various networks and health systems. This step supports CommonWell's ongoing goal of improving care coordination and access to vital health data.

### Expanding Membership and Network Reach

In tandem with its platform enhancements, CommonWell has continued to grow its membership, further expanding its network of healthcare providers. Three new members, AxiomEHR, Nightingale Technology, and RXTrail, have recently joined the alliance, reflecting the organisation's steady growth. Since its inception in 2013, CommonWell has expanded from six founding members to more than 70 members, now connecting over 36,000 provider organisations. This rapid expansion demonstrates the alliance's success in creating a scalable, interoperable healthcare network.

In addition to expanding its membership, CommonWell has facilitated the exchange of more than 7.7 billion health records supporting over 238 million patients. By linking more providers and improving data exchange capabilities, the alliance is contributing to nationwide efforts to make patient information more accessible, leading to better-informed medical decisions and improved patient outcomes.

### Aligning with TEFCA and Nationwide Interoperability Efforts

The recent platform upgrades and membership growth are occurring as CommonWell aligns itself more closely with TEFCA, a federally-backed initiative designed to standardise and expand health information exchange across the United States. TEFCA was developed in response to the 21st Century Cures Act, aiming to create a unified and secure framework for health data exchange. CommonWell, a TEFCA-qualified network, is positioning itself as a critical player in this nationwide effort.

Moreover, CommonWell's collaboration with Carequality—a separate but complementary interoperability initiative—further strengthens its reach. Carequality, which links more than 45 networks and over 50,000 clinics and hospitals, is also moving toward alignment with TEFCA. Both organisations have been exchanging data for years, and their ongoing cooperation could pave the way for an even broader, more seamless exchange of patient data in the future. The alignment of these two initiatives marks a crucial step toward achieving nationwide interoperability, helping ensure that health data is easily accessible to providers regardless of location or system.

### Conclusion

CommonWell Health Alliance's recent advancements, including its enhanced platform and alignment with TEFCA, represent a significant leap
