"We expect Agfa HealthCare's technology will help us streamline communication between departments and result in fewer repeated studies."

Administrators, radiologists, PACS administrators, technologists, clinicians, and IT specialists all gain workflow advantages when using IMPAX Enterprise. Its features, navigation tools, and display modes are designed in a flexible and intuitive way so that they can be tailored to individual preferences. Users can match the applications to their work habits. The voice recognition reporting solution, part of IMPAX Enterprise, will allow SRHS radiologists to very quickly and efficiently turn around reports.
