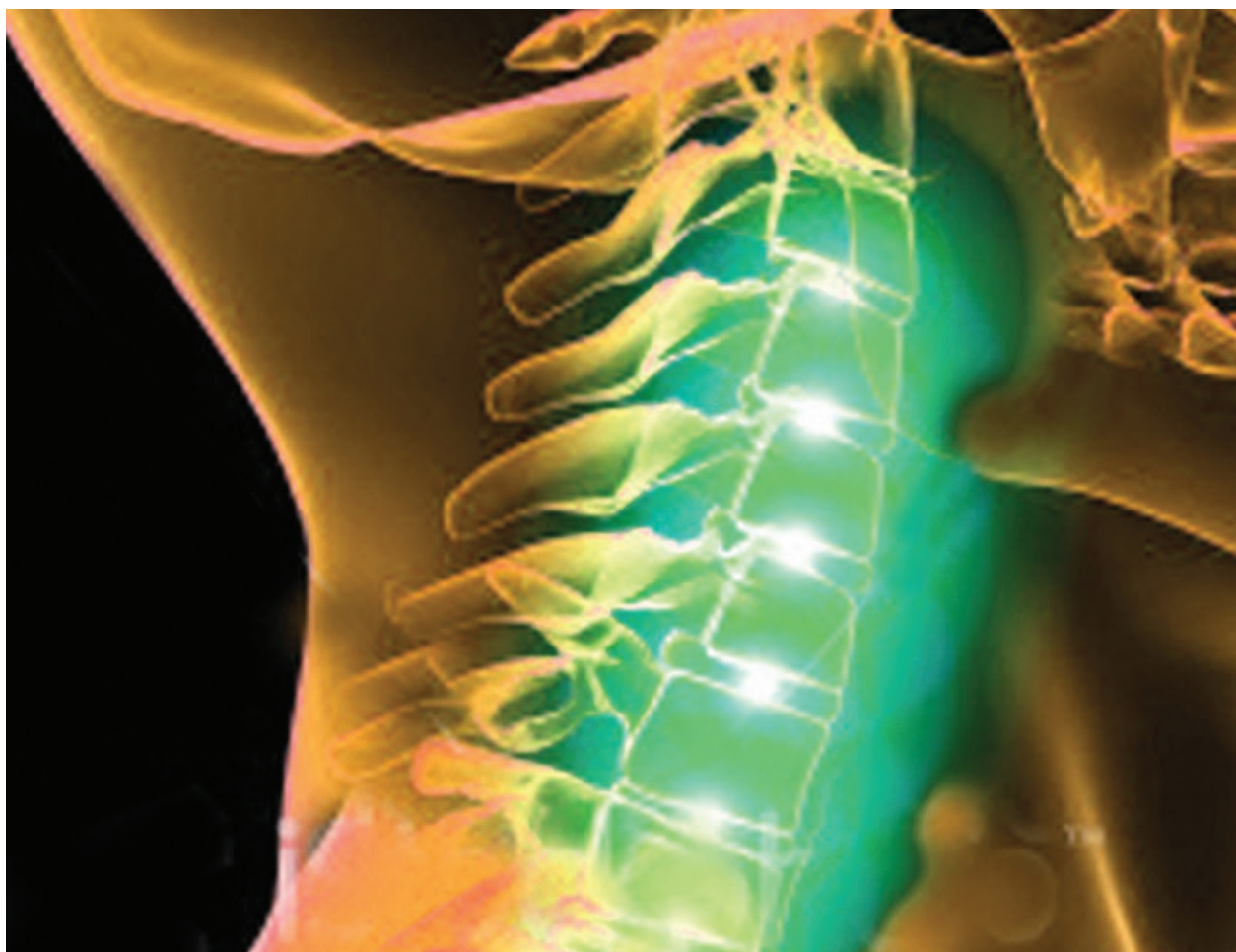

Conference Aims

This course aims to build on the successes of the last six years and will explore the issues surrounding cutaneous malignancy of the head and neck. The day will consist of evidence-based lectures that will focus on the management of a variety of skin and adnexal cancers including non-invasive diagnostic testing, the assessment of regional nodes, the role of adjuvant treatment and targeted therapies.
